a. Brown Act Training: Mr. Soriano explained that the Brown Act Training has been postponed to February. There will be more information to follow.

b. Governance Training

Mr. Soriano updated the board on the Governance Training self-paced modules. An email invitation from the Charter School Development Center (CSDC) should have been sent to each board member to access the training modules. If a board member has not received the link, please contact Mr. Soriano. The logins expire after 30 days, if not completed and new logins will be reissued.

c. Suicide Prevention Policy: Mr. Soriano confirmed BEST academy has a suicide prevention policy. The San Diego County Office of Education has a standard policy that our charter has adopted. BEST would like to look at the policy in accordance with parent training and online learning. There will be an updated policy in February.

d. Curriculum Data Presentation: Mr. Mays explained Northwest Evaluation Association (NWEA) evaluation system that demonstrates demographics, NWEA scores and assessments. These evaluations assist BEST in having a benchmark for student achievement in Lexia, Beable, RosettaStone, and Achieve3000. Mr. Mays showed graphics portraying student achievement levels. There will be another evaluation in April to compare academic growth and areas that need improvement. BEST is partnering with a new program that delivers weekly parent educational webinars in a variety of areas from suicide prevention to college information presented in English and Spanish. Mr. Soriano explained the importance of parent involvement and the direct effect it has on the student and their school work improvement. Mr. Mays added that empowering the parents of our students is an investment in the student's education.
